FREQUENTLY ASKED QUESTIONS/TERMS & CONDITION OF TRANSACTION

Q1. Where is ZION SMART CITY, EZI-OBODO OWERRI?

- A. **ZION SMART CITY OWERRI** is an undeveloped parcel of land situated in **Ngor Okpala Close to Zion Ministry**
- Q2. Who is the owner and promoter of the Estate?
- A. PWAN PRO REALTORS AND ESTATES LIMITED
- Q3. What type of Title does ZION SMART CITY Owerri have on the land?
- A. Registered Survey and Deed of Assignment.
- Q4. Is the road to the Estate motorable?
